Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at time 13:00, 2024/10/24 at the office of Kalinchok Rural Municipality, Office of the Rural Municipal Executive, Sunkhani, Dolakha. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
