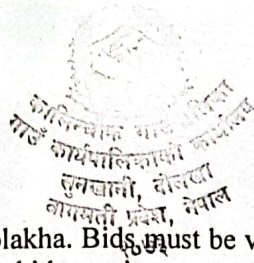

4. Sealed or electronic bids must be submitted to the office Kalinchok Rural Municipality, Office of the Rural Municipal Executive, Sunkhani, Dolakha by hand/courier or through PPMO website www.bolpatra.gov.np. on or before 12:00 P.M., 2024/11/20. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at time 13:00, 2024/11/20 at the office of Kalinchok Rural Municipality, Office of the Rural Municipal



Executive , Sunkhani, Dolakha. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid .
